# ORDINANCE COVERING COMPOSITION OF THE GREATER ROUND LAKE FIRE PROTECTION DISTRICT

IT IS HEREBY ORDAINED by the Board of Trustees of the Greater Round Lake Fire

Protection District, Lake County, Illinois, as follows:

### Section 1 Composition of Department

The Greater Round Lake Fire Department shall consist of the following personnel:

- 1 Fire Chief
- 2 Deputy Chiefs
- 3 Battalion Chiefs
- 9 Lieutenants
- 28 Firefighter/ Paramedics

Up to 35 Part-Time Firefighters

- 1 Fire Marshal (Non-sworn)
- 1 Assistant Fire Marshal (non-sworn)
- 1 Office Manager (Non-sworn)

#### Section 2 Application of Ordinance

It is the intent of the District to authorize two Deputy Chief positions during a transition period in anticipation of a Deputy Chief's retirement. Upon the retirement of a Deputy Chief, the District shall review this organizational structure and determine whether to return to one authorized Deputy Chief position appointed by the Board of Trustees.

### Section 3 Effective Date of Ordinance

This Ordinance shall be in full force and effect upon its adoption.

#### Section 4 Conflicting Provisions

This Ordinance shall supersede any ordinance, resolution, motions or parts of such which in any way conflict with any part herein. And any such ordinances, resolutions or motions or parts thereof are hereby repealed to the extent of any conflict.

#### Section 5 Invalidity

If any section, paragraph, or provision of this ordinance shall be held to be invalid or unenforceable for any reason, such invalidity or unenforceability shall not affect any of the remaining provisions of this ordinance.
